**Dance Auditions:** The audition is on March 14, 2009 at 9 a.m. During a 30 minute barre, modern dance phrase and jazz dance phrase, dancers will be evaluated on their flexibility, technique and musicality. In addition, they will be given an opportunity to present a solo. Recording playback equipment will be available. Appointments required. **Dress:** Women–leotards, footless tights, and ballet slippers. Men- Preferably the same or jazz pants. Hair must be worn off the face and neck. Bring warm-up clothes, as there will be a waiting time between interviews.

**Acting Auditions:** The audition is on March 12, 2009 at 7 p.m. and consists of an introductory acting class led by the Performing Arts faculty. Students must wear loose, comfortable clothing. Assessment is based on creativity, energy, commitment and ability to take direction. Students will be notified if they are called back for a second audition. **Appointments are required.** 

**Musical Theater Auditions:** The audition is on March 14, 2009 at 1 p.m. Musical Theater candidates must prepare and perform sixteen bars of a song and bring the sheet music for the accompanist. Students will perform a monologue and a brief dance phrase will be taught and performed. Assessment is based not only on creativity, energy, commitment and ability to take direction, but also on voice and movement capabilities. Students will be notified if they are called back for a second audition. **Appointments are required.**
