## INTERIM FMS PRINCIPAL CONTRACT

It is agreed between the **FRANKLIN TOWNSHIP BOARD OF EDUCATION** in **SOMERSET COUNTY, NEW JERSEY** and **Dr. Reginald Davenport** that the Board of Education has retained and does hereby employ the said **Dr. Reginald Davenport** as an Interim Principal, and to provide such expertise and to perform such services as the Board may require, during the term described herein, to assure the satisfactory operation of the public schools. The services contemplated by this Contract shall generally be described as those responsibilities performed by a Middle School Principal in the school district.

The period of this Contract will begin as of **December 16, 2015**, and end on or about **June 30, 2016 as needed**. This Contract may be terminated prior to said date upon thirty (30) calendar days written notice by either party. During the Contract period, **Dr. Reginald Davenport** will perform services on a pro-rated salary basis of \$135,000 annually, payable according to the District's regular payroll. It is understood that the aforesaid payments are subject to any deductions required by law.

**Dr. Reginald Davenport** agrees that his employment will be governed by the terms and conditions and he will receive the same employment benefits as a member of the Franklin Township School Administrators Association. **Dr. Reginald Davenport** agrees that he will not be paid for any unused paid time off at the conclusion of his interim employment in the school district.

**Dr. Reginald Davenport** hereby accepts the position aforesaid and agrees that he: will maintain valid New Jersey educational certification necessary to perform the responsibilities required of him under this Contract; will faithfully do and perform his duties under the position aforesaid; and will observe and enforce the rules and regulations prescribed for the government of the school by the Board of Education.
