

**Consent to Release Student Information/Photograph
& Consent to Use Student Information/Photograph
on Web Site/Internet**

The Franklin Township Public Schools are justifiably proud of the accomplishments and activities of our students.

To celebrate those accomplishments and activities, the District may wish to announce or publicize certain student achievements, activities, and events. In addition, reporters from news media organizations may occasionally attend various school-sponsored activities and may take pictures and/or publish an article about the activity or event.

The purpose of this Consent Form is for you to both inform you and to request permission to release your child's photo/video/image and other personally identifiable information to the **public and media**, and to use your child's photo/video/image **and** other personally identifiable information **on the District's website**, social media and other Internet-based media. **There are two parts to this form, please read, sign both and return it to your child's school.**

Part 1 - Consent to Release Student Information/Photograph to the Public and Media:

The District may wish to announce or publicize certain student achievements, activities, and events, including by such methods as press releases to or contact with local and national news media; sports activity sheets such as a wrestling competition forms which show the weight and height of the team members; playbills and programs for fine and performing art events; honor roll or other recognition lists; presentations at Board of Education meetings; publication in District or school-based brochures/newsletters/newsmagazines; and/or broadcasting on our local Board of Education TV Station.

In addition, reporters from news media organizations may occasionally attend various school-sponsored activities, such as academic presentations, art exhibits, athletic events, awards, community service activities, concerts, contests, district presentations, honors, honor roll(s), music, outstanding academic work, outstanding educational initiatives, plays, special programs, sports, and/or public meetings. They may request to take pictures of your child and/or publish an article about the activity or event. Your child may also be interviewed and quoted.

This information may also be part of a Board of Education meeting which has been recorded, and may be broadcast on our local Board of Education TV Station, and/or other television stations should they provide coverage. We also may publish student names on recognition, club membership or other similar lists as appropriate.

It is possible that news media organizations may obtain "directory information" and/or photographs or video footage from District publications and/or during press coverage and include it in their publications and/or on their Web sites.

Directory information means information contained in an education record of a student that would not generally be considered harmful or an invasion of privacy if disclosed, and includes, but is not limited to, the student's name; address; telephone listing; electronic mail address; photograph; date and place of birth; major field of study; grade level; enrollment status (e.g., undergraduate or graduate, full-time or part-time); dates of attendance; participation in officially recognized activities and sports; weight and

height of members of athletic teams; degrees, honors, and awards received; and the most recent educational agency or institution attended.

Directory information does not include a student's Social security number or student identification (ID) number, except as permitted by law.

While Federal law permits the District to release the information listed above, *without* your express consent, the purpose of this Consent Form is for you to please indicate whether you will allow us to do so or if you would prefer for us not to release this information to the public and/or use this information on the District's website(s), social media, and other Internet-based media.

Public and media outlets include, but are not limited to, printed and/or on-line newspapers and/or magazines, websites, blogs, local and national radio and/or television news sites and/or social media platforms, as well as the Franklin Township Public Schools' own website, our social media platforms, and other Internet-based media, and/or public presentations or displays in buildings throughout the District and the greater community, such as, but not limited to, your child's school, other District buildings, government buildings and/or area malls and/or universities.
