**CONTRACT BETWEEN THE
FOUNDATION FOR EDUCATIONAL ADMINISTRATION
AND
FRANKLIN TOWNSHIP BOARD OF EDUCATION
TO PROVIDE TRAINING IN
504 AND I&RS**

WHEREAS, the Foundation for Educational Administration (hereinafter referred to as "FEA"), with principal offices located at 12 Centre Drive, Monroe Township, New Jersey, 08831-1564 and the Franklin Township Board of Education, with principal offices located at 1755 Amwell Road, Somerset, NJ 08873 intend to enter into an agreement in order that the FEA shall provide training in the area of the **504 and I&RS** for those staff members employed by the Franklin Township Board of Education.

NOW, THEREFORE, be it resolved that each of the aforementioned agree to the following:

1. SERVICE TO BE PROVIDED: FEA shall provide **2 half day sessions** of in person instructions in the area of **504 and I&RS** to staff members employed by the **Franklin Township BOE**.

A. The training shall consist of **2 half day sessions** covering the following:

- 1) **504 training on September 24, 2013**
- 2) **I&RS training on September 30, 2013**

B. The training shall include approximately **50 participants**.

C. Materials shall be provided by the FEA.

2. COST: The Franklin Township BOE agrees to pay FEA a total payment of Five Thousand Dollars (\$5,000.00) for the 2 half day training sessions.


